02. Eligibility / Mandatory.

- i). Valid Registration Certificate upto June 2021 and onwards with Pakistan Engineering Council in relevant category and specialized codes as mentioned against work.
- ii). At least 2 works having same specifications and nature each having equal or more quantum (in terms of quantities) completed during past three years duly supported with completion certificates and SPPRA ID's showing Bid evaluation reports.
- iii). Bio data of Engineering and Technical staff working with the firm.
- iv). Annual turnover at-least twice per annum, to the estimated cost of the work applied, in last 3 years (turnover will be evaluated from annual returns and Audit Reports).
- v). Annual audited reports of last three years from (ICAP) registered audit firm. Audit report issued from not (ICAP) registered audit firms will not be accepted.
- vi). List of Machinery and equipment available with documentary evidence of its ownership/rented.
- vii). Documentary evidence showing the contractor / firm owns/ rented an Asphalt Plant along with its related machinery such as Tandom, PTR and Paver machine.
- viii). Certificate of Bank showing credit worthiness of at-least 15% of the estimated cost of work along with Bank Statement. Bank statement must be provided separately for each year starting from 1st July to 30th June for last three years and recent bank certificate must be attached showing available balance.
- ix). Registration with Income Tax Department (NTN certificates) with activate status with Federal Board of Revenue.
- x). Annual Income Tax returns of last three years.
- xi). Registration Certificate of Sindh Revenue Board Government of Sindh (SRB) certificate (with Active Status).

03. **Method of Procurement (Single Stage two envelops) Must contain 02 separate sealed envelops for technical & financial otherwise such tender will not be entertained.**

04. **Bidding / Tender Documents.**

- i). Contract documents and other terms and conditions can be seen and issued from office of the undersigned on payment of tender fees shown against work or can be downloaded from the official website of SPPRA i.e "ppms.pprasindh.gov.pk". The bid security mentioned above **in the shape of call deposit only from any scheduled bank of Pakistan in favour of the Executive Engineer, Provincial Highway Division Hyderabad showing on account of (Name of firm)** should be attached with the Technical Bid / Tenders, otherwise such tenders will not be entertained.
- ii). Manner of Bid Security other than CD-R will not be accepted.
- iii). Evaluation Criteria, sub-criteria, for the evaluation of Full Technical Proposals is based on Yes / No OR Pass / Fail; a bidder fails to obtain Yes or pass in any sub-criteria then he / it shall not be qualified.
- iv). The tender will be opened in presence of the Procurement Committee / participating contractors / firms and their authorized representatives, who may wish to be present.
- v). Bid shall comprise Single Package containing two separate envelops. Each envelop shall contain separate **Financial Proposal** and **Technical Proposal**.
- vi). **TECHNICAL PROPOSAL** opened, shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened on the date and time that will be communicated in writing to all the qualified contractors / firms in advance. Financial bids / proposals shall be returned unopened to respective bidders in case technically bidding document (s) found non-response or rejected.
- vii). The CD-R's of the technically responsive bidders but rejected due to higher rate will be returned back after the issuance of work order to the successful bidder.
- viii). In case of any member of procurement committee happens to be out of Head Quarter on the date of opening bids will be submitted and opened on next working day on same schedule.
- ix). Joint Venture will not be allowed.
- x). Fresh affidavit with effect that all the documents / particulars / machinery information furnished are true and correct. In case of Bogus / Tempered or false information / certificates provided by the company / firm shall be liable to be black listed at any stage.
- xi). Details of owner along with CNIC on Fresh Judicial Stamp paper, a representative should have authority on Judicial Stamp Paper from owner.
- xii). In case of Firm, giving full particulars of Directors / Proprietors or other connected information along with Power of Attorney. In case of being sole proprietors such undertaking on Affidavit be furnished.
- xiii). Undertaking on fresh stamp paper that firm is not involved in any kind of litigation with, any departmental rift, abandoned or unnecessary delay in completion of any work awarded to him.
- xiv). Fresh affidavit to this effect that the Firm / Contractor have not been black listed previously by any executing agency.
- xv). The Tenders should be submitted along with the above required documentation / Information. If any of such required documents / information lacking than the tender will not be considered by the procurement committee and no excuse will be entertained.

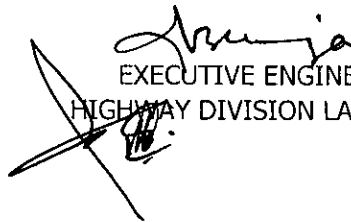
