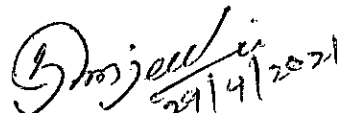
According to SPPRA Rules 2010 (amended 2019), sealed tenders are invited from the interested firms/contractors for execution of the following works:-

- a). Bidding will be conducted as Single Stage - 'Two Envelope Procedure' as per SPPRA 2010 (amended 20-19) Rule 46-2 and will be opened to all eligible Bidder.
- b). The blank tender documents can be obtained from the office of Director, Govt. Special Education & Rehabilitation Complex, Karachi w.e.f the date of publication on any working day.
- c). The tender documents for the works will be issued on submission of application and payment of tender fee, as mentioned above.
- d). The parties/firms/contractors will submit the following.
 - i) Copy of CNIC of Proprietor or partners.
 - ii) Copy of Proprietorship /Partnership Deed.
 - iii) Copy of NTN Certificate and sales Tax, Registration with FBR.
 - iv) Three (3) years Experience in relevant field.
 - v) Financial Turnover at least 3 years (Bank statement or Bank certificate).
 - vi) Undertaking/affidavit on stamp paper that the firm is not involved in any litigation / arbitration or has not abandoned any work or has never been black-listed in any department.
 - vii) Etc.
- e). The party must be submit the bid security/earnest money in shape of pay order/call deposit in favor of Director, Govt. Special Education & Rehabilitation Complex, Karachi, with the bid documents. In case of non-submission of bid security/earnest money the tenders will be rejected.
