- List of machinery and equipment available with documentary proof of its ownership.
- Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.

- The bidder should have experience of such works and should have completed at least 2 similar works (List to be provided with bid).
- The bidder should be well versed with the site conditions and should have completed at least 2 No's works under similar conditions (List to be provided with bid).
- Affidavit to the effect that firm has not been black listed previously by any executing agency.
- Affidavits to the effect that all documents / particulars / information furnished are true and correct.
- Conditional Tenders will not be entertained.
