2. The intending contractors shall have to get them self registered or renew their previous registration up to 29-12-2016 through an application accompanied with receipt of Challan or cash Rs.500/- for new registration @ Rs.200/- for old registration, for renewal duly credited in the National Bank Pakistan under the Head of Account 1233-Jails as registration fee, which is non refundable. No application for registration or renew will be accepted after expire of described date.

3. That tender form can be obtained from the office of the Deputy Commissioner Tando Allahyar, by the registered contractor only on any working day during office hours. No tender other then on the prescribed form will be accepted.

4. The words "TENDER FORM" should be written on envelop addressed to Deputy Commissioner Tando Allahyar.

5. Security deposit of 1% of the value of contract shall have been deposited under the head "Revenue Deposited" and receipt thereof attached with the tender form no tender will be accepted without earnest/security deposit.

6. The tender should be accompanied by receipt of copy of the Challan having been deposited as an earnest money / security deposit at 1% of the total cost of the last year.

7. The scale of supply of diet shall be in accordance with the provisions as laid down in articling No: 472,173,175 of Pakistan Prisoners rule and Notification No: SO(BUD)HD-4(1)/2009(Jails) Dated: 20-04-2009 my the secretary to Government of Sindh Home Department Karachi

8. The rate of Judicial Lock-Up and Police Lock-Up situated on and the same place and should not differ or offered in the Tender form.


