- iv) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board (SRB), (Sales Tax Registration) and copy of CNIC.

- vi) Undertaking on stamp paper that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- vii) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- viii) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- ix) Affidavits to the effect that all documents / particulars / information furnished are true and correct.

- xi) Conditional Tenders will not be entertained.
