2. Bidding Documents can also be downloaded from SPPRA Website i.e. www.pprasindh.govt.pk. and sindh.gov.pk/dpt/HOME/index.htm.
3. The bids will be received back up to 05.01.2017 at 11:00 am and will be opened on the same day at 11:30 am in the presence of Procurement Committee and the bidders or their authorized representatives who wish to be present.
4. The firms must provide proof of registration with the tax department.
5. The firm shall ensure best quality furniture items.

6. The firm will be required to submit security deposit (refundable) amounting to 2% of the total value of the bid in the shape of pay order in the name of the Section Officer (Admn), Home Deptt. Karachi.
7. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
8. Conditional Bid and Bid without bid security shall not be considered.
9. Delivery time will be 45 days starting from the date of issuance of supply order.
10. GST/Income Tax certificates, as the case may be, must be accompanied with the tender.
11. The Bid submitted by bidder shall be submitted inclusive of all applicable taxes.
12. The bid that is lowest & responsive to all the terms and conditions of tender shall be decided successful under the SPP Rules 2010.
