Envelopes shall be marked as **“FINANCIAL PROPOSAL”** and **“TECHNICAL PROPOSAL”** in bold and legible letters to avoid confusion.
2. Interested Manufactures/Suppliers and authorized dealers may obtain the tender document along with tender fees Rs.500/- each items from Mr. Arif Shah, Assistant Sub-Inspector of Special Branch Karachi Cell No.0300-9252074 & Office No.021-99212666, 5th Floor Central Police officer I.I. Chundrigar Road, Karachi by submitting an application on their letter head along-with tender fees from **15-01-2018 to 30-01-2018**.
3. Sealed tenders on prescribed proforma in duplicated along-with 2% earnest money of the total bid in the form of Pay Order (Payee's A/c in favour of DIGP Special Branch Karachi) should be dropped in the tender box kept in office of DIGP Special Branch, 5th floor, Central Police Office, I.I. Chundrigar Road Karachi on **31-01-2018 at 1400 hours**.
4. The tender shall be opened on **31-01-2018 at 1500 hours** in Presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room of DIGP Special Branch Karachi 5th floor, I.I. Chundrigar Road Karachi.
5. Only Manufactures/Suppliers and authorized dealers registered with Income Tax and Sales Tax department are eligible to participate in the tenders (Documentary proof required).
6. Only bids offered on the prescribed tender form issued by the Special Branch Karachi shall be accepted. However, additional sheets may be attached, if required.
7. Conditional tender / application will not be entertained.
8. Competent authority can cancel the bidding process at any time prior to the acceptance of a proposal as per provision of Rule-25(1) of SPPRA Rules, 2010 (Amended 2017).
