TERMS AND CONDITIONS OF THE TENDER:

- The intending participants can submit their bid under **SINGLE STAGE-TWO ENVELOPE** procedure adopted for tender process for purchase of the furniture and fixture containing two separate envelopes. Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as "**FINANCIAL PROPOSAL**" and "**TECHNICAL PROPOSAL**" in bold and legible letters to avoid confusion and reject of Bid. While for the Demolition, Repair and Maintenance/Renovation works of Boundary wall for the project under ADP Scheme No.830/2017-2018 & Repair, Maintenance / Renovation work of existing Collage Building the participant shall submit bids under Single Stage One Envelope procedure.
- Interested bidders may obtain the tender form alongwith the specification of work from office of Principal/Project Director Shaheed Mohtarma Benazir Bhutto Medical Collage Lyari, Karachi by submitting an application on their letterhead and tender fee in form of Pay order/Demand Draft alongwith copies of NTN and Sindh Revenue Board.
 - The last date of receipt and submission of tender form is 12-03-2018 upto 02:30 pm which will be opened on 13-03-2018 at 12.00 Noon. The conditional tenders will not be entertained.
 - The procuring agency may accept/reject the tender subject to the relevant provision of SPPRA Rules.2010
 - Only bid offered on the prescribed tender form issued by the office of Principal/Project Director Shaheed Mohtarma Benazir Bhutto Medical Collage Lyari, Karachi shall be accepted. However additional sheet may be attached if required.
 - Only contractors registered with Income Tax and Sindh Revenue Board are eligible to participate in the tender.
 - Bidder are required to quote the charges in local currency (Pak Rupees).
 - Prescribed Tender Proforma alongwith copy of Terms and Condition can be obtained from purchase of this NIT on the payment, as mentioned in the above schedule in the shape of Pay Order (Non refundable) from the Office of Principal/Project Director, Shaheed Mohtarma Benazir Bhutto Medical College Lyari on production of following documents.
 - Income Tax Registration Certificate.
 - GST Registration Certificate.
 - Valid Certificate of Pakistan Engineering Council.
 - The intending participants for Demolition, Repair and Maintenance/Renovation works of Boundary wall for the project under ADP Scheme No.830/2017-2018 and Repair, Maintenance / Renovation work of existing Collage Building should have valid license with Pakistan Engineering council with C-5 category or above.
 - Tenders should be dropped in the tender box kept in the Office of Principal, Shaheed Mohtarma Benazir Bhutto Medical College Lyari Karachi. All bids must accompany bid security @ 2.5% of total bid cost in shape of pay order / bank draft.
 - As per relevant provision of SPP Rules 2010, the Purchase Committee may cancel/delete any item/(s) or decrease or increase the quantity or order for part supply, part payment as per requirement. Parties/Participants who do not fulfill the Terms & Condition will not be entertained.
 - Usual taxes shall be deducted under the standing rules.
 - All the Bids submitted after the given time shall not be accepted.
 - The Government notified black listed firms/suppliers shall not be entertained.
 - In case the tender is not opened on schedule dates due to any unavoidable circumstances, then the same shall be opened on next working day.
