



Terms & Conditions:

1. Eligible candidates who are holding domicile of Sindh and fulfil the requisite eligibility criteria may appear for test/interview in the office of Sindh Food Authority, Food Department, Government of Sindh, Bungalow No.D/47, Clifton Block-1, Karachi on **Wednesday 26th December, 2018 at 10:00 A.M.** along with copies of the relevant certificates / testimonials / degrees and 03 passport size photographs mentioned against post.
2. Candidates already in Government service should apply through proper channel/ having NOC from respective department/organization failing which their candidature will not be accepted.
3. If any documents provided by candidate are found bogus or tempered during the recruitment process and afterwards the appointment will be annulled and recovery proceedings shall be initiated.
4. Women/Disable & Minorities quota shall also be observed /maintained strictly according to existing rules/policy of Government of Sindh.
5. Selection candidates shall not have any right of regularization into service whatsoever.
6. SFA shall have authority to terminate services of any candidate if found unsuitable at any time without assigning any reason.
7. The general upper age relaxation limit will be allowed as per Sindh Government policy.
8. No TA/DA shall be admissible for test/interview.
