



NOTIFICATION

NO.SOJI/8-1/2014 (LEAs-Uniform): Whereas, the Director General, Rangers (Sindh) has requested to impose ban permanently under section 144 (6) Cr.P.C, on the following activities to improve the law & order situation in the Province:

- i. Sale of Armed forces / Security Agencies / Para Military /Police Uniform cloth by the mills to general traders except authorized agents of various services carrying authority letter of the concerned Force HQ.
- ii. Stitching /Sale / Display of such uniforms in Bazaars /Markets.

AND WHEREAS, the Government is satisfied that in order to maintain law & order and to curb the use of such uniforms of the law enforcing agencies by unauthorized persons, it is expedient to take necessary measures in the Province of Sindh.

NOW THEREFORE, the Government of Sindh in exercise of the powers conferred under Section 144 (6) of Cr.P.C, hereby impose complete ban on above mentioned activities in the Province of Sindh with effect from 1st December 2014 for a period of 30 days.

In pursuance of Section 195 (1) (a) Cr.P.C, the police officers not below the rank of S.H.Os of concerned Police Stations are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.P.C against the violators of this order.
