ORDER

- Inter-Departmental coordination, in this connection, where required.

NOTE:

- No Department/Entity of Government of Sindh shall send reports to PILDAT, unless the consultation with Focal Person has been made by the Department/Entity, and the recommendation has been obtained from the Focal Person for such transmission of data.
- As and when required by the Focal Person, the Department/Entities of the Government of Sindh shall immediately depute a well conversant officer to assist the Focal Person for sharing of data of that Department/Entity and general coordination with the Focal Person. A separate notification, to the effect of nomination of Departmental Focal Person, will be issued by the Chief Minister's Secretariat, in consultation with the Focal Person.
