7. The bidders are requested to give their best and final prices as no negotiations are expected.

8. The bidding method will be **Single Stage-one envelope procedure**. The firms shall prepare two envelopes i.e. the bid shall comprise a single package containing two separate sealed envelopes each envelope shall contain separately **TECHINCAL PROPOSAL** (with catalogue / literature, country of origin / brand and sample) and **FINANCIAL PROPOSAL**.
