
8. Technical proposal must contain company profile with following information.

 - c. Details of Machinery and equipment available for execution of work with documentary evidence and can be physically verified during scrutinize technical proposal by undersigned or any representative.
 - d. Qualification and experience of technical personnel with names and their cell numbers key site management staff (Last 3 Years).
 - e. Bank statement of last 03 years i.e **08/2016 to 07/2019**, confirming cash availability **10% of the estimated cost of each work verified from recognized bank** and financial capability must have Annual turnover **200%** of the estimated cost of each work.
 - f. Current affidavit that the firm is not indulged in litigation and has not abandoned works.
