2. **Eligibility: (Documentary evidences to be submitted with the proposal for each work separately):**
- Valid Pakistan Engineering Council (PEC) registration in the category C-4 or above and discipline (CE04, CE09 & CE10) for Construction and Operation of Engineering works,
 - Valid NTN Certificate from Federal Board of Revenue.
 - Valid registration Certificate from Sindh Revenue Board (SRB) for Sales Tax.
 - Provided Affidavit that the firm is not Blacklisted or engaged in any litigation on any project or by any organization.
3. **Pre-qualification (PQ) Documents.**
Applications are invited from interested firm for short-listing. Interested firms can obtain the pre-qualification documents upon written request from the address mentioned below. The request must clearly state "**Request for Pre-qualification for work – 1 or 2 (name of work)**". The documents are available for a non-refundable fee of Rs.3,000/- in shape of Pay Order in favour of Managing Director WASA HDA Hyderabad. In case of downloading the PQ documents from the SPPRA website, non-refundable fee must be submitted at the time of submission of Proposal.
4. **Issuance:**
Documents will be issued from the date of publication up till 01st January 2019 in working hours, on payment of prescribed fee (Non-refundable) in the shape of Pay order in the name of Managing Director Water & Sanitation Agency (WASA) HDA Hyderabad.
Documents will be issued only on submission of copies of Valid PEC Registration Certificate in category stated above and valid NTN Certificate.
