 - vi). The procuring Agency may reject all or any bid Subject to the relevant provision of SPPRA Rules.

4. Under taking on Affidavit that firm is not involved in any litigation or abandoned any work in the department.
5. The bidders should submit bid security as showing against each work in shape of call deposit / pay order prepared from the scheduled bank in favour of the undersigned.
