Brief Scope of Work of Sindh Police

Sindh Police intends to start recruitment of Police Constables in Hyderabad Range.

Proposals are invited from reputed Testing Services Firms with requisite qualification and experience to provide for following services.

- Conduct Written and psychometric Tests for candidates for recurrent of Police Constables in Hyderabad, Dadu, Thatta, Badin, Sujawal, Jamshoro Matiari, Tando Allahyar & Tando Muhammad Khan in accordance with the Sindh Police Recruitment Policy.
- Biometric verification of all candidates on the spot prior to their entry for above mentioned tests.

ELIGIBILITY

- Legal status of the organization including registration in GST/Income Tax Sindh Revenue Board.
- Execution plan for services required by the Recruitment Committee.
- Profile of the organization.
- Detail of experience in similar type of assignments for (05) years experiences of Recruitment process of law Enforcement Agencies/Police throughout Pakistan. The Recruitment Process must include data entry of candidates, issuing examination slips to the candidates for prescribed test.
- Provide evidence of conducting atleast 03 assignments the company have handled / processed 5000 or more candidates.
- Availability of qualified human resource, including manager and field staff proficient in relevant field.
- Affidavit of being not blacklisted by any government/public organization not defaulter of any scheduled commercial bank and noninvolvement in any litigation.
