**3- Eligibility Criteria:-**

- i) Average turnover for the last three years must be minimum Rs.200 million per annum. (Three years audited financial accounts required)
- ii) Minimum 100 projects successfully completed during last 5 years in Pakistan. List of units installed required.
- iii) Minimum 200 units under maintenance in Pakistan. Certificates of satisfactory performance required from at least 10 clients under maintenance.
- iv) Minimum 10 years experience in supply, installation and maintenance of elevators.
- v) Minimum 10 years agency relationship of firm/agents with the supplier/Principal.
