 - ii) Bio-data of Engineers & Technical staff working with the firm alongwith Engineering Qualification Certificate.
 - iii) List of Machinery and equipment available with documentary evidence of its ownership, as required under chapter 4.2 (j) as SPPRA, Certificate bank showing credit worthiness alongwith Bank Statement of Last Two years.
 - iv) Annual Turnover Atleast three years, the estimated cost of the work applied, in last three years.
 - v) Annual Audited reports of last three years from registered audit firm
 - vi) Certificates of Bank showing credit worthiness of Atleast 15% of the estimated cost of work applied alongwith Bank Statement.
