- Attested photocopy of Computerized National Identity Card (C.N.I.C.)
- In case of limited companies and partnership firms, attested copy of Memorandum of Articles of Association and Registered Partnership Deed.
- Attested copies of Income Tax Certificates of last three years with National Tax Number.

- Statement of bank account for the last two years.
- To Prove five year work experience as Government Contractor in related field.

Note: The scrutiny will be held by the Members of Auction Committee on the same day before auction proceeding all above documents must be completed otherwise no excuse of the participants in the auction, shall be accepted. The period of contract for rights to collect Excise Duty on specified minerals will be awarded for the period upto 30th June, 2020.

A complete set of Terms and Conditions of auction and the contract, mentioning all terms and conditions, can be purchased from the office of the Commissioner, Mines Labour Welfare Sindh on payment of Rs. 1000/- (Rupees One Thousand Only) each, (Non-refundable) on any working day during working hours on or before **12.07.2019** which should be carefully examined and followed by the intending bidder. The first highest bidder will be required to deposit a security equal to 10% of final highest bid on the next working day, in the shape of Bank Draft / Pay Order in favour of Commissioner, Mines Labour Welfare Sindh.

- As per Income Tax Law under Section 236-A of Income Tax Ordinance 2001, the successful bidder will have to deposit in advance 10% withholding tax on contractual amount at the time of award of contract through Income Tax challan.
