

- 2- The bids will be received back on **27-03-2019** up to 2.00 p.m. and will be opened on the same day @ 4.00 p.m. in presence of Procurement Committee and the bidders or their authorized representatives who wish to be present on the occasion. - i) Documentary evidence of minimum 3 works of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
- ii) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- iii) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- iv) Annual turnover of at least 40% of the bid cost for the last three years.
- v) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- vi) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- vii) Certificate of bank showing credit worthiness along with current bank statement.
- viii) Undertaking on stamp paper that firm is not involved in any kind of litigation, departmental rift, abandoned or unnecessary delay in completion of any work in the Government and as well as in private organizations.
