 - (ii) Bio-data of Engineers & Technical staff working with the firm alongwith Engineering Qualification Certificate.
 - (iii) list of work in progress, indicating cost of each work and copy of letter of award of work.
 - (iv) List of machinery and equipment available with documentary evidence of its ownership, as required under chapter 4.2 (j) as SPPRA, Bank certificate showing credit worthiness alongwith Bank statement at least 20% of the applied work cost.


