

3- **Eligibility / Conditions:-**


- i) For electrical work valid license issued from Inspectorate of Electrical License Sindh of the similar region with respect to works, shown above.
- ii) List of work and copy of letter of award of work / work orders of equivalent cost or above (Experience of relevant works).

- iii) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board (SRB)/ (Sales Tax Registration) and copy of CNIC.
- iv) Undertaking on stamp paper that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- v) Turn-over of at least three years for relevant amount works or more.
- vi) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- vii) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- viii) Affidavit to the effect that all documents / particulars / information furnished is true and correct.
